- 1. The Candidate has to submit the following certificates in original for verification at the time of admission
 - i. HSC/SSC /10th Pass Certificate and Mark Sheet
 - ii. +2 /Sr. Secondary /Intermediate Certificate and Mark Sheet
 - iii. +3/Graduation Certificate and Mark Sheet
 - iv. Master Degree Certificate and Mark Sheet
 - v. If completed M.Phil., then proof of M.Phil. Certificate and Mark Sheet
 - vi. Fellowship award letter
- vii. Proof of additional qualification if any
- viii. SC/ST Certificate issued by the competent authority (wherever applicable).
 - ix. OBC (non-creamy layer) Certificate issued by competent authority. It should not be more than six months old (wherever applicable). SEBC certificate shall not be entertained.
 - x. PWD/ Ex-Servicemen Certificate issued by the competent authority (wherever applicable).
- xi. Copy of publications, if any
- xii. A research proposal on which candidate is interested to do Ph.D. with a powerpoint presentation
- xiii. A brief curriculum vitae
 - Candidates have to submit one set of self-attested photocopies of all the relevant certificates, mark sheets, testimonials, and other important documents wants to produce.
- 2. No Candidate shall be entitled to claim admission as a matter of right and the University reserves the right to refuse admission in any individual case without assigning any reason thereof.
- 3. If at any time, it is discovered that the candidates made a false or incorrect statement and used fraudulent means to secure admission, his/her candidature shall be cancelled.
- 4. No TA/DA shall be paid for coming to participated in the viva-voce test.
