- 1. The Candidate has to submit the following certificates in original for verification at the time of admission
 - i. Rank Card
 - ii. HSC/SSC /10th Pass Certificate and Mark Sheet
 - iii. +2 /Sr. Secondary /Intermediate Certificate and Mark Sheet
 - iv. +3/Graduation Certificate and Mark Sheet
 - v. Original College/School Leaving Certificate
 - vi. Original Migration Certificate
- vii. Any kind of undertaking shall not be entertained for all above certificate (Except migration certificate).
- viii. SC/ST Certificate issued by the competent authority (wherever applicable).
- ix. OBC (non-creamy layer) Certificate issued by competent authority. It should not be more than six months old (wherever applicable). SEBC certificate shall not be entertained.
- x. Candidates have to submit four copies of recent passport size photograph.
- xi. PWD/ Ex-Servicemen Certificate issued by the competent authority (wherever applicable).
 - Candidates have to submit one set of self-attested photocopies of all the relevant certificates and mark sheets along with original Leaving Certificate and Migration Certificate.
