TERMS & CONDITIONS:

I. ESSENTIAL QUALIFICATION:

The tenderer shall fulfill the following eligibility criteria, failing which their quotations will be summarily rejected:

- a. The tenderer must be a Civil contractor possessing valid C-class and above License, Registration etc. issued by the Competent Authority as applicable.
- b. They must have experience in execution of Civil works value of Rs. 05 Lakhs or above in any Public Works Department or having experience of execution of works of value of 10 lakhs during last five years.
- c. The tenderer must deposit Earnest Money (EMD) of Rs.8,000/- (Rupees Eight Thousand Only) along with their tender in the form of Demand Draft drawn in favour of Central University of Orissa payable at Koraput.
- d. The tenderer must deposit the cost of tender document of Rs.500.00 (Rupees Five hundred only) in the form of demand draft drawn in favour of Central University of Orissa payable at Koraput. The cost of the tender document is nonrefundable.
- e. The tenderer must possess his own Bank Account in any nationalized bank, PAN, TAN and GST Registration No.
- f. The quoted rates by the tenderer shall be inclusive of all taxes duties, freight charges, supervision charges.
- g. The GST will be reimbursable on production of document to that effect of depositing GST.
- h. The works should be executed as per the PWD norms of Govt. of Odisha.
- i. The tenderer must be capable of organizing of man power, materials and equipments at the work site within 3 days of receiving work order.
- j. The work to be completed satisfactorily within 60 days of receiving work order on urgent basis.
- k. He shall furnish the photocopies of documents as specified in the Annexure along with the tender papers.

- 5. Demand Draft of Rs 8,000/- (Rupees Eight Thousand only) drawn in favour of Central University of Orissa payable at Koraput towards value of EMD.
- 6. Demand Draft of Rs.500.00 (Rupees Five Hundred only) towards cost of tender document drawn in favour of Central University of Orissa payable at Koraput which is not refundable.

III. INSTRUCTIONS TO THE BIDDER:

- 1. Bid Opening Date and Time: The tenderers may send their quotations by speed post or registered post or in person (to be dropped in tender box)only addressed to the Registrar, Central University of Orissa, Landiguda, Koraput, Odisha–764021 so as to reach the University on or before 10.07.2018 by 15.00Hrs. Super-scribed as "Tender for the work of Construction of waiting hall in front of Girls' Hostel at CUO, Main Campus, Sunabeda. Ref. No: XXXVII-217/2018/152, date- 15.06.2018". The bids will be opened at 15.30 hrs on the same day in the presence of representatives of the bidders if any.
- 2. The bids sent through normal post or courier or Fax or e-mail shall not be considered.
- 3. Central University of Orissa, Koraput reserves the rights to accept / reject any offer in full or in part without assigning any reason thereof.
- 4. The blank bid documents may be downloaded from the University Website <u>www.cuo.ac.in</u>
- 5. Penalty: If the bidder fails to start the work or perform the services by the specified date, penalty at the rate of 1% per week of the total Contract / Work Order value subject to the maximum of 10% will be deducted.

- 6. Payment: payment will be released after completion of the work.
- 7. Security Deposit (Performance Security Deposit): The successful tenderer shall deposit @5% of the total contract value as Security Deposit within 03 days from the date of issue of Work Order, in the form of Demand Draft issued by any Nationalized Bank, drawn in favour of Central University of Orissa payable at Koraput. The same shall remain with the University till two months after the completion of the work and will be returned without any interest.
- 8. Settlement of Disputes: In the event of any dispute or differences between the Central University of Orissa and the tenderer, arising out of non-performance of the work or un satisfactorily performance of work with reference to given estimate specification, quality or quantity of work or whatsoever reasons relating to the work, during or after the completion of work shall be referred to the Vice-Chancellor, Central University of Orissa, Koraput who may decide the matter himself or may appoint Arbitrator under the Arbitration and Conciliation Act, 1996. The decision of the Arbitrator shall be final and binding on both the parties. All disputes shall be subject to jurisdiction of courts in Orissa only.
- 9. The tenderer shall replace the goods and would attend the defects if any notices or pointed out to the satisfaction of the University within a reasonable time period.
- 10. Return of EMD: The EMD of the unsuccessful bidders / tenderers will be returned within 15 days after finalization of the tender and issue of Work Order to the successful tenderer. The EMD of the successful tenderer will be returned on submission of Security Deposit of the required value.
