### **TERMS & CONDITIONS:**

#### I. ESSENTIAL QUALIFICATION:

The tenderers shall fulfill the following eligibility criteria, failing which their quotations will be summarily rejected:

- a. The tenderer must possess valid License, Registration etc. issued by the Competent Authority as applicable.
- **b.** If the quotationer is the authorized dealer / sole distributor of the items, the Certificate to this effect should be attached.
- **c.** The quotationer must have satisfactorily completed:
  - i. One work Order/Purchase Order of Rs.15.00 Lakhs or more
  - ii. Two works orders/Purchase Orders of Rs.10.00 lakhs each or more or
  - Three works orders/Purchase Orders of Rs.5.00 Lakh or more issued by any Govt. / Autonomous/ PSU Organization (Central or State) for supply of same or similar item / services during the last 03 Financial Years (i.e. 2016-17, 2017-18 and 2018-19).

Note: (i) The work in progress and work which is not satisfactorily completed will not be considered; (ii) Supply / work executed in any private organization will not be considered.

- d. The total turnover of the tenderer shall not be less than Rs.01.00 Crore during the last 03 Financial Years (2016-17, 2017-18 and 2018-19).
- e. The tenderer must deposit Earnest Money (EMD) of Rs.75,000/- (Rupees seventy five thousand only) along with their tender in the form of Demand Draft drawn in favour of Central University of Orissa payable at Koraput.
- f. The tenderer must deposit the cost of tender document of Rs.500.00 (Rupees Five hundred only) in the form of demand draft drawn in favour of Central University of Orissa payable at Koraput. The cost of the tender document is non-refundable.
- g. The tenderer must possess his own Bank Account, PAN, and G. S.T No.

#### II. DOCUMENTS TO BE ENCLOSED

# The tenderer shall submit copies of the following documents along with the tender, failing which their quotation will be summarily rejected:

- 1. Copy of registration / license issued by the Competent Authority.
- 2. Work Completion Certificate issued by the authority with reference to Sl.No.C above consisting of the following details:
  - i. Description of items supplied / installed
  - ii. Installation Order No. & Date
  - iii. Value of installation Order
  - iv. Date of commencement of supply / installation
  - v. Date of completion of supply / installation
  - vi. Quantity supplied / installed
  - vii. Whether supply / installation completed or not
- 3. Copy of income tax returns and / or annual accounts of the last 03 Financial Years.
- 4. Copies of Bank Account, PAN, and Goods and Services Tax Registration Certificate.
- 5. Demand Draft of Rs.75,000/- (Rupees seventy five thousand only) drawn in favour of Central University of Orissa payable at Koraput towards value of EMD.
- 6. Demand Draft of Rs.500.00 (Rupees Five hundred only) towards cost of tender document drawn in favour of Central University of Orissa payable at Koraput which is not refundable.
- 7. Certificate of dealership / distributorship as applicable.

#### **III. INSTRUCTIONS TO THE BIDDER:**

- 1. **Bid Opening Date and Time**: The tenderers / quotationers may send their quotations by speed post or registered post or in person only addressed to the Registrar, Central University of Orissa, Landiguda, Koraput, Odisha 764 021, Odisha so as to reach the University on or before 04/06/2019 by 15.00Hrs. Superscribed as "Tender for the work of ...... Ref. No....date......." The bids will be opened at 15.30 hrs on the same day in the presence of representatives of the bidders if any.
- 2. The rates and specifications quoted by the tenderers shall be strictly as per the Proforma attached as Annexure -02 and 03 otherwise their quote will be liable for rejection.
- 3. The bids sent through normal post or courier or Fax or e-mail shall not be considered.

- 4. All the documents submitted by the tenderers shall be serially numbered.
- 5. Central University of Orissa, Koraput reserves the rights to accept / reject any offer in full or in part without assigning any reason thereof.
- 6. The blank bid documents may be downloaded from the University Website <u>www.cuo.ac.in</u>
- 7. Tenders / Bids must be valid for 120 days from the date of opening of tender.
- 8. The quantity required may vary as per the requirement of the University.
- Delivery Period: The items shall be supplied, installed and commissioned within 15 days from the date of issue of Supply Order. Delayed supply / installation will attract levy of penalty/liquidated damages.
- 10. **Penalty:** If the bidder fails to perform the services by the specified date, penalty at the rate of 1% per week of the total Contract / supply Order value subject to the maximum of 10% will be deducted.
- 11. **Payment:** 100% payment will be released after satisfactory supply / installation and commissioning stores.
- 12. **Security Deposit** (Performance Security Deposit): The successful tenderer shall deposit @5% of the total installation / contract value as Security Deposit within 07 days from the date of issue of installtion Order, in the form of Demand Draft issued by any Nationalised Bank, drawn in favour of Central University of Orissa payable at Koraput. The same shall remain with the University till two months after the completion of warranty period and will be returned without any interest.
- 13. **Installation & Warranty:** The tenderers / bidders shall extend comprehensive on-site warranty of at least 02 years from the date of successful installation. The installation shall be free from all defects and shall be of the highest quality.

Any defect arises shall be reinstalled free of cost by the tenderer. Further, the University shall have the right to recover the cost of inconvenience caused to the University for failure to provide uninterrupted service of the installations during the warranty period.

14. **Settlement of Disputes:** In the event of any dispute or differences between the Central University of Orissa and the bidder, arising out of non-supply of material or goods, not found as per specifications or any other cause whatsoever relating to the installation order before or after the supply has been executed, shall be referred to the Vice-Chancellor, Central University of Orissa, Koraput who may decide the matter himself or may appoint Arbitrator under the Arbitration and Conciliation Act, 1996. The decision of the Arbitrator shall be final and binding on both the parties. All disputes shall be subject to jurisdiction of courts at Orissa only.

- 15. **Return of EMD:** The EMD of the unsuccessful bidders / tenderers will be returned within 15 days after finalization of the tender and issue of installation Order to the successful tenderer. The EMD of the successful tenderer will be returned on submission of Security Deposit of the required value.
- 16. **Condition of goods:** The bidder / tenderer shall install in good condition without any defect whatsoever to the satisfaction of the university. Any deviation in the material and the specifications from the accepted terms is liable to be rejected and the quotationers need to reinstall on free of cost in the specified form to the satisfaction of the University.
