The details of the eligible and not eligible candidates along with the reason(s) of the rejection of their candidatures are mentioned as referred above. No correspondence/mails will be sent to Not Eligible candidates. However, some candidates have been recommended by the Committee subject to comply with the certain conditions prescribed against their name. As per the recommendations of the Screening Committees, the eligibility of the candidates would continue to be provisional subject to final verification of the documents/certificates etc., before selection. If it is detected by the CUO, Odisha at any point of time in future that the academic credentials and other relevant documents are submitted by the candidate are not genuine or the candidate was not eligible for the post as per the prescribed educational qualifications and experience etc., which could not be detected during the selection process due to whatever circumstances, the candidature of the concerned candidate shall be liable to cancel as per rule.

Since the number of eligible applicants for the position of Deputy Registrar is not very large, the Screening Committee decided that all eligible applicants who meet the minimum eligibility requirements may be short-listed to be called to appear before the Selection Committee for expert assessment and interview. Decision with regard to short-listing of applicants to be called to appear before the Selection Committee for expert assessment and interview, has been made on the basis of their claim/information/certificates furnished/attached in their application forms. Although all efforts have been made to ensure accuracy in preparing the both lists mentioned above, possibility of inadvertent error or typographical mistake / omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any.

Accordingly, all the candidates are required to go through the recommendations of the Screening Committees and in case of any grievance relating to their rejection of candidature for the post, the candidate may submit request with relevant supporting documents to recruitmentcell@cuo.ac.in on or before 15.07.2021 (Up to 05:00 PM) failing which no request shall be entertained in this regard. Anomaly(s) shall be rectified as per rule, if any.
