### Important Instructions:

Candidates are advised to read carefully and comply with these instructions, as also the instructions given by the Invigilator / Centre Superintendent at the test centre.

- 1. Reporting Time: Considering COVID-19 Pandemic related Government Guidelines and to maintain 'Social Distancing, all candidates are requested to report at least 45 Minutes prior to the commencement of the test at the allotted test centre.**
2. No candidates will be allowed to enter the test centre after 20 minutes of commencement of examination in each session.
3. Candidates should also bring their Photo ID Proof in original for verification purpose. Photo ID Proof may include any one of the following: (i) Election ID Card (ii) Pan Card (iii) Driving Licence (iv) Photo ID issued by School/University or by the Employer (v) Passport (vi) Aadhaar Card. IN ABSENCE OF ORIGINAL PHOTO ID PROOF, **CANDIDATES WILL NOT BE ALLOWED TO ENTER IN THE TEST CENTRE PREMISES.** E-Aadhar card is not valid for Photo ID proof for verification purpose in the examination.
- 4. Candidate must bring his/her recent passport size photograph to be pasted on the attendance sheet.**
5. Carry a black/blue ball pen to fill the OMR sheet.
6. **MOBILE PHONES/ PAGERS/ CALCULATORS/ SCANNING DEVICES/ ANY OTHER ELECTRONIC GADGET/ SCALES/ ALGORITHM TABLES** are strictly prohibited inside the test centre. Test centre will not be responsible for its safety/loss.
7. The candidates will not be permitted to leave the examination hall till the end of the examination in a given session.
8. Wearing a mask/face cover is mandatory for all candidates. Candidates without mask/face cover will not be allowed into the examination centre.
9. If a candidate has any symptom of COVID-19, he/she should inform the examination centre in-charge.
10. All guidelines issued by GoI regarding COVID-19 are to be strictly followed.
