The recruitment shall be made in accordance with the guidelines of UGC Regulations 2018, AICTE Notification, 2019 and NCTE Regulations, 2014 as applicable.

# I. ASSOCIATE PROFESSOR OF SCIENCES, SOCIAL SCIENCES, HUMANITIES, JOURNALISM & MASS COMMUNICATION, AND LANGUAGES

#### **Essential:**

- i. A good academic record, with a Ph.D. Degree in the concerned /allied /relevant disciplines.
- ii. A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii. A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in the Screening Guidelines (Appendix II, Table 2. of UGC Regulation 2018)

### II. ASSOCIATE PROFESSOR OF BUSINESS MANAGEMENT

Ph.D. degree in the relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch.

**AND** 

At least 6 (six) research publications in SCI journals/UGC/AICTE approved journals

**AND** 

Minimum 8 years of experience in teaching/research/industry out of which at least 2 years shall be post Ph.D. experience.

### III. ASSOCIATE PROFESSOR OF EDUCATION ESSENTIAL:

- i. Postgraduate degree with minimum 55% marks in Sciences/ Mathematics/ Social Sciences/ Languages/ Commerce.
- ii. Post graduate degree in Education (M.Ed. / M.A. Education) with minimum 55 % marks
- iii. Ph.D. degree in Education or in the discipline relevant to the area of specialization.
- *iv.* A minimum of eight years of experience of teaching and/or research in an academic/ research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in the Appendix II, Table 2 of UGC Regulations 2018.

## GENERAL NOTE ON QUALIFICATION AND RELAXATION:

i. A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (non-Page 5 of 8

creamy layer)/ Differently abled {(a) Hearing Impairment (HI), (b) Visual Impairment (VI) including blindness and low vision, and (c) Locomotor Disability (LD) including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d)} for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

- ii. A relaxation of 5% may be provided to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.
- iii. Any other criteria prescribed by the UGC/AICTE/NCTE but not mentioned above, shall be applicable.

### **GENERAL INSTRUCTIONS FOR APPLICANTS:**

- 1. All applicants are required to apply online in the prescribed format (on CU-Chayan) with complete, correct information and attachments. The applicant will be solely responsible for the authenticity of the submitted information. Applicants are required to fill the application form as available on the CU-Chayan Portal/University website www.cuo.ac.in.
- 2. The details regarding qualifications and experience are available on the University website <a href="www.cuo.ac.in">www.cuo.ac.in</a> along with this advertisement. The applicants are required to read these details before filling up the form.
- 3. Applicants should possess the prescribed qualifications and experience as on the closing date of application, as prescribed by the University for the Respective Posts. The posts advertised carry UGC pay scales plus admissible allowances.
- 4. The applications received shall be screened as per screening guidelines for short-listing and recommending the applicants to be called for interview. Mere fulfillment of the qualification or the eligibility criteria does not entitle an applicant to be necessarily considered or called for interview.
- 5. Publications 'under submission' or submitted to referees shall not be considered towards calculation of marks for publication criteria.
- 6. Academic /Research Score shall be calculated as per criteria given in Appendix II, Table 2 of the UGC Regulation 2018. Each Academic/Research score must be supported by the documentary evidence (copy of publications, project sanction letter, utilization and completion certificates issued by the University and acknowledgements for patent filing and approval letters, students' Ph.D. award letter, etc) that could be objectively verified without which no claim on score wouldbe entertained.
- 7. Ph.D. Degree shall be a mandatory qualification for appointment to the post of Associate Professor.
- 8. The time taken by candidates to acquire M.Phil. and/or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment.

- 9. Applicants seeking reservation benefits available for SC/ST/OBC/EWS/PwBD categories must upload the necessary documents in support of their claim as per Govt. of India lists/rules/norms and in the prescribed form(s) issued by Competent Authority.
  - Applicants applying under the category of OBC and EWS must upload respective certificates OBC (non- creamy layer) and EWS in the prescribed form(s) issued by Competent Authority. The certificate must be of the current financial year.
  - In case the applicant wants to claim benefits under the PwBD category (4% horizontal reservation available), the applicant's relevant disability should not be less than 40 per cent. Proof to this effect in the form of a valid Disability Certificate must be uploaded with the application.
- 10. Consequent upon adoption of self-certification provisions as required by the Govt. of India, the University shall process the applications entirely on the basis of information/documents uploaded with the application. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility shall lie with the applicant and the applicant shall be liable for action as per law.
- 11. Applicants serving in Government/Public Sector Undertakings (including Boards/Autonomous Bodies) are required to submit original 'No Objection Certificate' from the employer at the time of interview. However, they have to upload the copy of the 'No Objection Certificate' during submission of online application.
- 12 The University will verify the antecedents of the applicant at the time of appointment or anytime during the tenure of the service. In case it is found that the documents/information submitted by the candidate is false or the candidate has suppressed relevant information, the services of the candidate shall be terminated without prejudice to any other action initiated by the University.
- 13. The University reserve the rights for partly/fully cancel the recruitment at any stage of the recruitment process
- 14. The screened/shortlisted candidates called for interview should report along with all the testimonials/certificates in original along with valid photo ID (Aadhar/Voter ID/Driving License/Passport). A set of self-attested photocopy of certificates/testimonials in respect to the qualifications, experience and category as applicable, indicated in the online application form should also be submitted at the time of interview.
- 15. No TA/DA shall be paid to candidates for attending interview.
- 16. All correspondence from the University including interview letter, if any, shall be sent only through the e-mail address provided by the applicant in the online application form. Any change of address/contact given in the application form should at once be communicated to the University failing which the University shall not be held responsible.
- 17. The University reserves the right to amend the number of posts or not to fill any of the posts mentioned in the advertisement without assigning any reason thereof. Any consequential vacancies arising at the time of interview may also be filled up from the available screened candidates.
- 18. Applicants must NOT furnish any particulars that are false, tampered or fabricated, or suppress any material / information while submitting the application online and uploading self-certified copies/testimonials.
- 19. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issuance of offer letter, the University reserves right to modify/withdraw/cancel any communication made to the applicants.

- 20. National Pension Scheme in accordance with the O.M.No.1 (13) EV/2001, Govt. of India, Ministry of Finance, Department of Expenditure, dated 15.03.2004, will be applicable with subsequent amendments made or will be made from time to time.
- 21. Application fees and application form(s) are to be submitted as per details given below:
  - i. Application Fees: Rs.1000/- for UR/OBC/EWS category.
  - ii. No application fee will be charged from applicants from SC, ST, PwBD category and Women applicants.
  - iii. Fees once paid will not be refunded under any circumstances.
  - iv. Payment should be made through *Payment Gateway* given in the online CU-Chayan portal.
  - v. Applicants applying for more than one post/department must apply separately and pay fees separately.

- 26. Any dispute regarding the recruitment will fall under the jurisdiction of courts of Odisha.
