Conference Note

The changing role of women in society has traveled from a feudal, patriarchal form of relations to a more flexible liberal social order based on democratic principles in the twenty-first century. With the wake-up call of global climate change, the world is moving toward conserving natural resources and the sustainable environment of the earth. Save the environment and save the earth are popular global slogans today among academicians, researchers, youth, leaders, bureaucrats, environmental activists, etc. The need to conserve the environment is essential today due to various threats: population, ethnology, deforestation, infrastructure development, war, migration, etc.

The connection between women, the environment, and sustainable development has been sparked since the early 1960s but largely remained confined to the writings in books, journals, periodicals, and newspapers only. The early 1980s witnessed the concern shown by policymakers and governments across the world regarding the symbiotic relations between the environment and gender issues. In 1991 the World Bank pointed out that women play an important role in the management of natural resources, including soil, water, forest, agriculture, and energy.



In the context of Women, Environment, and Development, the dialogue about women in development emerged and advocated that for women's economic status to be improved in developing countries focus needs to be on Women, Environment, and Development when issues of manmade pollution, environmental hazards, garbage, and waste disposal, uses of pesticide, chemicals, nuclear test, disposal of electronic wastes, etc., remain a major environmental concern across the world. Women, Environment, and Development concerns highly emphasize women as solution providers to environmental issues but without substantial policies directed at empowering women.
